QUALIFICATION ROUND RULES AND INFORMATION SHEET

1. U.S.G.A. Rules govern play with these exceptions:
 - A. Local rules listed on Supplemental rules sheet
2. Format: 18 holes stroke play.
 - A. 16 low scores will qualify for Match Play. Ties for last qualifying spot will be played off as soon as groups have completed qualifying round. Play-offs will begin on Hole #1. The 2009 winner will be exempt from qualifying for the 2010 event
3. Medalist will receive Crystal Award and NCGA Points, all qualifiers will receive NCGA Points and \$50.00 Golf Shop Credit.
4. Players may call the Golf Shop, (559) 432-3020 for Match Play Pairings and Qualifying Tee Times

MATCH PLAY RULES AND INFORMATION SHEET

1. U.S.G.A. Rules govern play with these exceptions:
 - A. Local rules listed on the supplemental rule sheet.
2. Format: Match Play Rule 2. Stipulated Round shall be 18 holes. For the purpose of settling a tie, the Stipulated Round shall be extended to as many holes as are required for a match to be decided. Play – offs will begin on Hole #1.
3. A Referee will be assigned to each Match. Definition of a Referee: A “Referee” is one who is appointed by the Committee to accompany players to decide questions of fact and apply the Rules. He shall act on any breach of a Rule which he observes or is reported to him. A referee should not attend the flagstick, stand at or mark the position of the hole, or lift the ball or mark its position. A referee” decision shall be final Rule 34-2.
4. PM Matches for both days are scheduled for 30 minutes after opponent has completed AM Match.
5. 2009 Match Play Champion will be exempt from qualifying in 2010. N.C.G.A. Points will be awarded to winners as per indicated on page 128 of the 2000 N.C.G.A. Blue Book. Crystal Awards for Champion and Runner-up. Golf Shop credit for all finalists.
